




Is personalized patient care a priority in 2019 for your PBM?


Is improvement in member education a priority in 2019 for your PBM?


What is your PBM currently using to support member education related to their medication therapy?








Could you envision a percentage of your members taking short-courses (8-15 mins) on their medication therapy on their own (self-directed eLearning)?


Could you envision your clinicians sharing specific therapeutic short-courses 1-on-1 with individual members?




